- Eligible candidates for the above contractual position will be interviewed at the Committee Hall, ICAR-Tuticorin Regional Station of CMFRI, Thoothukudi-1.
- Only passed-out graduates are eligible to apply. Candidates awaiting the result are not qualified and need not apply.
- 4. The crucial date for determining the age limit shall be the interview date.
- For SC candidates, an age relaxation of five years will be given as per the Govt. of India/ICAR rules.
- 6. The above position is purely temporary. The appointment will be co-terminus with the project's termination. Other terms and conditions will be as per the revised ICAR guidelines for recruiting Young Professionals and Field Assistants in ICAR.
- 7. The selected candidate will have no right whatsoever for absorption/regularization in the institute.
